OBLIGATIONS OF DATA FIDUCIARY

CONSENT AND DEEMED CONSENT

Consent should be obtained in a **freely**, and Data Principal's **unambiguous indication** should also be there.

Data Principal has the Right to withdraw the consent at any time.

Deemed Consent :

1. Voluntarily give her consent
2. Performance of any function under any law.
3. For responding to a medical emergency
4. For complying with any judgment.
5. In public interest
6. For any Fair and reasonable purpose.



GENERAL OBLIGATIONS

1. Shall take reasonable efforts to ensure that by taking reasonable efforts, the data processed is accurate and complete.
2. it shall protect the data security safeguards.
3. In the event of data breach, it shall inform the board about the same.

ADDITIONAL OBLIGATION

1. Before Processing the data of a child, the data fiduciary has to take consent from Parents and guardians.
2. It shall not undertake **tracking or behavioral monitoring** of children.
3. It shall not undertake such processing of personal data that is likely to **cause harm** to a child,

NOTICE

1. Before requesting the Data principle for her consent, an itemized notice shall be given to her.
2. if consent has been given commencement of the act then also they have to give notice to the Data Principle act,

RIGHTS OF DATA PRINCIPLE



RIGHT TO INFORMATION ABOUT PERSONAL DATA

the data principle have
the right to obtain:

1. Confirmation.
2. Summary
3. In one place, the identities of all the data has been shared.
4. Any other information

RIGHT TO CORRECTION AND ERASURE OF PERSONAL DATA

The Data Principle shall have the right to correct and erase her personal data.

RIGHT TO GRIEVANCE REDRESAAL

the right to readily available means of registering a grievance with a Data Fiduciary. A Data Principal who is not satisfied with the response of a Data Fiduciary receives no response within seven days may register a complaint to a board.

RIGHT TO NOMINATE

In the event of death and incapacity of the data principal, she shall have the right to nominate someone on her behalf to exercise all her rights
